## Built Environment\*

### LINZ Consultation on Changes to Landonline Terms and Conditions

(January 2019)

Provided formal response after undertaking analysis, including legal ramifications. Proposed changes lacked clarity and gave LINZ disproportionate power exceeding the disciplinary provisions of the CSLB under the Cadastral Survey Act 2002. Also, because of the potential impact of the privacy waiver on members we recommended that the Office of the Privacy Commissioner be consulted, and that Landonline conditions formally include CSLB as a consultative party

### Surveyor-General's Consultation on the Rules for Cadastral Survey 2010 - Stage 2 Part 2

(March 2019)

Formal response submitted on the consultation document setting out the proposed changes. A wide range of members' views were presented
