Registrations for this year's conference are now open!

Hosted under the theme 'The New Normal' the conference will focus on topics around recovery, reshaping and resilience and will look ahead at the challenges and opportunities for our sector in the wake of Covid19.

The conference will take place in Rotorua on the 3rd and 4th of November.
