## NEW ZEALAND INSTITUTE OF SURVEYORS AWARD

**Origin:** This award was established by the New Zealand Institute of Surveyors in 1974 to recognise the value of the work carried out by Technicians within the scope of the profession.

## PERCY DYETT AWARD

**Purpose:** The award was established from a legacy from the estate of Henry Lewis Percy Dyett, Fellow of the New Zealand Institute of Surveyors and Member of the Survey Board for 23 years from 1942 - 1965.
