#### **COASTAL OTAGO**

Like everyone else, The Coastal Otago Branch has had a very busy year.

For our local members, and their firms, there is a high demand for the services that we offer and future workloads are considerable. The amount of work is causing delays in completion times and some starting times are now having to be pushed out. However, this position is not unique to surveying and is a reflection of the disruption and delays that are occurring across the New Zealand economy and around the World. Given time, we will return to a more sustainable situation but the short-term view remains as being difficult to manage for businesses and individuals.

A significant concern for most firms is finding qualified employees at all levels within their businesses to employ. As the World opens back up for travel, I expect that this will become worse as some of our young professional look to start their OE which they have postponed for the last two years. For those of us that completed our own OEs years ago, we know that this is an important part of their professional development. However, that doesn't change the difficulties that employers will have to manage as fully qualified staff head off overseas. We can only hope that relaxing immigration restrictions and returning professionals will relieve some of these pressures.

At the Branch level, we have successful progressed our program of encouraging and engaging with the Young Professionals that are in our region. The steering group has starting networking in order to better understand the needs of wider group. The social connections that already exist will hopefully develop more interactions and it will be important for the Branch to continue to support this effort.

The School of Surveying continues to be an important aspect of membership within our branch. We are well served by the mixture of practicing consultants and academic knowledge that is available.

Looking forward, the limited space for new residential allotments continues to be an issue. We have seen the successful completion of the demolition phase on the site of the new Dunedin hospital and now look forward to seeing some activity as the construction phase begins.
