In preparation for the full rollout of the Certification Programme, we introduced a trial Education and Training Levy for all Voting members to use in the 2022/23 financial year. This levy is being well-utilised with over 370 attendances of various events at no fee since this was brought in!

The levy entitles Voting members to unlimited access to a substantially increased range of live and recorded webinar topics during the year. We have brought this levy in to make the cost of CPD more manageable and to encourage members to access events in preparation for greater CPD compliance requirements in the years ahead. In addition, part of the activities we will undertake will be to simplify the process of recording members' CPD points.

2022 SPATIAL EXCELLENCE AWARDS

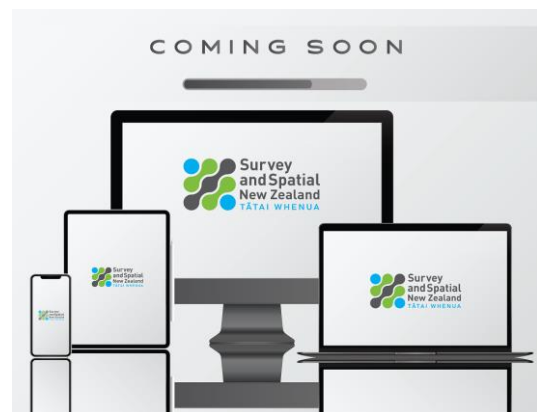





can sit for their Professional Entrance Examination. 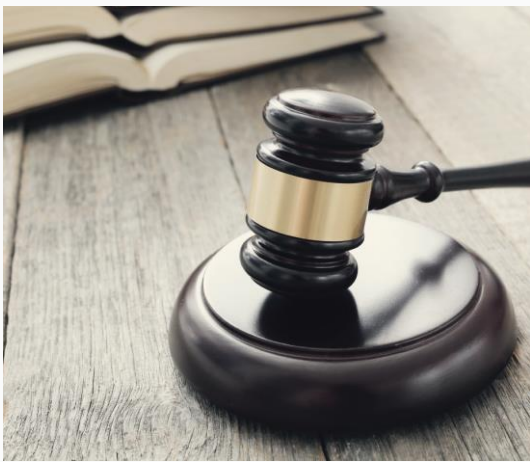
