### **Landonline and ASaTS Update - Landonline as a Service**

This change is significant from an IT perspective, but in reality users should notice very little difference. “Landonline as a service” is a replacement for the existing Landonline Citrix server farm, so replaces the infrastructure that is used to support Landonline Workspace. You may have also heard of it referred to as DAAS (Desktop as a Service) for Workspace.

The Landonline application, database and all other infrastructure remains largely unchanged, so for a while we can progressively move users to the new service, keeping the existing Citrix farm active until all users are migrated. The first group will include a small a number of firms (approx. 40-50) and be referred to as a pilot.

A request is about to be sent out to a small a number of firms asking if they would like to participate in a controlled pilot. This group of firms has been selected because they are amongst those who have special requirements in respect to access through our current security layers. i.e. These are the most likely to encounter unexpected issues, if unexpected issues occur.

This upgrade is to the behind the scenes part of Landonline only. Users will notice very little difference to the way the system works. There will be some minor changes to the way the system looks – for example the “logoff” button will move to the top right of the screen – but otherwise there will be no change to the data users are required to enter or the way they move between screens.


It’s planned for the upgrade to take place from 14 December. Landonline would remain available when the upgrade is carried out.

### Recent Case Note Summaries

This month we report on seven court decisions covering diverse situations associated with subdivision, development and land use activities from around the country: Two of these decisions consider the matters of “reverse sensitivity” effects:

- A successful appeal against decline of consent of establishment and operation of a specialist dementia care establishment on rural land near a Tamarillo orchard at Lepperton, near New Plymouth
- An unsuccessful appeal by a land-owner against conviction for unconsented earthworks at Pauatahanui, near Porirua
- A further High Court decision relating to sale of a property at Duder’s Beach, Manukau
- An unsuccessful appeal against a decision of Heritage New Zealand for emergency authority to demolish an earthquake-damaged listed historic building at Christchurch; - Granting of enforcement orders against owners of a rural-residential property at Otatara near Invercargill for activities involving motor vehicle repairs and testing
- A successful application for judicial review of a decision to grant consent for a residential development on a property within a light industrial area at Te Atatu, Auckland
