



MEMORANDUM OF UNDERSTANDING

BETWEEN

PACIFIC GEOSPATIAL & SURVEYING COUNCIL (PGSC)

AND

NEW ZEALAND INSTITUTE OF SURVEYORS (NZIS)

INTRODUCTION

The Pacific Geospatial and Surveying Council (PGSC) is a body representing the geospatial and surveying authorities of Pacific Island Countries and Territories (PICTs) as the core membership. A wide range of other members are permitted including observers, experts, non PICT government agencies, academic institutions, commercial manufacturers, organisations of professionals and development partners.

The New Zealand Institute of Surveyors (NZIS) is the peak professional membership body supporting surveyors and spatial professionals in New Zealand and overseas.

These two bodies recognise each other as regional partners.

OBJECTIVE

To work together to enhance capacity and professional support in the Pacific Islands. To support efforts to implement the Sustainable Development Goals. To share information that benefits members of both organisations.

ADMINISTRATION

DURATION OF MEMORANDUM AND TERMINATION PROCESS

This MOU is for the benefit of the members of PGSC and NZIS

It is built on goodwill and a willingness to work together.

This agreement shall continue indefinitely from the date signed unless it is superseded by another MOU or terminated.

If disagreement occurs that cannot be resolved through best endeavours, then this memorandum may be terminated by either party giving three months' notice in writing.
